

PUBLIC WORKSHOP NOTICE

Webinar to Discuss Proposed Amendments to the Emission Inventory Criteria and Guidelines Regulation for the Air Toxics "Hot Spots" Program

The California Air Resources Board (CARB) is proposing amendments to the Emission Inventory Criteria and Guidelines Regulation and incorporated Report (collectively referred to as the EICG Regulation, or EICG) for the Air Toxics "Hot Spots" Program (AB 2588). The EICG Regulation provides facilities information on how to compile and report the types and quantities of toxic substances they routinely release into the air. CARB is scheduling a webinar on April 30, 2020, to discuss proposed amendments to the EICG Regulation. These proposed amendments are necessary to ensure comprehensive and up-to-date reporting of emission inventories and subsequent evaluation of health risks. The proposed amendments are also designed to support community-focused efforts at CARB to reduce criteria pollutant and air toxic emissions from California's most disadvantaged communities.

The EICG Regulation is Section 93300.5, Title 17, California Code of Regulations, and it incorporates by reference the Emission Inventory Criteria and Guidelines for the Air Toxics "Hot Spots" Program (including appendices), which was last amended August 27, 2007.
