Notice of Public Meeting to Consider Assembly Bill 617 Community Air Protection Program – Community Emissions Reduction Program for the Portside Environmental Justice Neighborhoods

The California Air Resources Board (CARB or Board) will conduct a public meeting at the date and time noted below to consider the Community Emissions Reduction Program for the Portside Environmental Justice Neighborhoods.

This item will be considered at a meeting of the Board, which will commence at 4:00 p.m., October 14, 2021.

Background

Assembly Bill (AB) 617 (C. Garcia, Chapter 136, 2017), signed into law in July 2017, requires new community-focused actions to reduce air pollution and improve public health in communities that experience disproportionate burdens from exposure to air pollutants. To implement this statute CARB established the Community Air Protection Program (Program), whose foundation is collaboration with communities and stakeholders to advance environmental justice and equity.

At its September 27, 2018, hearing, the Board approved the “Community Air Protection Blueprint” (Blueprint), which contains detailed requirements for community emissions reduction programs, community air monitoring plans, and other elements of the Program. ([Resolution 18-33](#).) At the same meeting, the Board also selected the first ten communities to implement community emissions reduction programs, community air monitoring, or both. Since then, the Board has selected five additional communities for these targeted local actions.

Once CARB selects a community to develop a community emissions reduction program, the local air district must work with the community to develop and adopt a community emissions reduction program. Subsequently, the air district must submit the community emissions reduction program to CARB for consideration.

CARB selected the Portside Environmental Justice Neighborhoods (Portside Community) for a community air monitoring plan on September 27, 2018, and for the transition to a community emissions reduction program on December 13, 2019. The San Diego Pollution Control District (SDAPCD) worked with a community steering committee to develop the Community Emissions Reduction Plan for the Portside Environmental Justice Neighborhoods (Plan) to reduce exposure to air pollution in the community. The SDAPCD Governing Board adopted Phase I of the Plan on November 18, 2020, and Phase II on July 16, 2021.

CARB staff reviewed the Plan to determine whether it: complies with the minimum criteria the legislation and the Blueprint established for community emissions reduction programs; reflects community priorities; and sets a foundation to deliver emissions and exposure reductions in the Portside Community. CARB staff also held a virtual community meeting on August 24, 2021, to hear directly from the Portside community members and other local stakeholders on their perspectives on the Plan. CARB staff released the *Portside Environmental Justice Neighborhoods Community Emissions Reduction Program Staff Report* on September 23, 2021, which contains a summary of the review and staff recommendations to the Board.

Proposed Action

The Board will hear about the contents of the CERP and consider CARB staff's recommendations for Board action contained in the *Portside Environmental Justice Neighborhoods Community Emissions Reduction Program Staff Report*.
