

**Proposition 1B: Goods Movement Emission Reduction Program  
Status of Projects Awarded FY2007-08 Funds (as of early December 2008)**

*Note: This status summary was compiled prior to the suspension of Program funding on December 19, 2008 due to the delay in enacting solutions to the current fiscal year budget crisis that is preventing the State Treasurer's Office from accessing the bond market to generate funds. The Air Resources Board (ARB) has instructed local agencies to suspend entering into new contracts or expending funds for contracts already signed because ARB is not authorized to approve payments for expenditure requests until such time as we have access to funds to cover Proposition 1B programs. Once Proposition 1B funds can be generated, Program implementation and expenditures can continue without further disruption.
