# NOTICE OF PUBLIC MEETING TO CONSIDER ENDORSEMENT OF AN UPDATED CALIFORNIA TROPICAL FOREST STANDARD

The California Air Resources Board (CARB or Board) will conduct a public meeting at the time and place noted below to consider the endorsement of the California Tropical Forest Standard

This item will be considered at a meeting of the Board, which will commence at 9:00 a.m., on September 19, 2019, and may continue at 8:30 a.m., on September 20, 2019. Please consult the agenda for the meeting, which will be available at least ten days before September 19, 2019, to determine the day on which this item will be considered. This item is not proposing any regulatory action.

#### California Tropical Forest Standard

The California Tropical Forest Standard (Standard) was originally released in September 2018 for a November 16, 2018 Board hearing. No action was taken on the Standard at the November 16, 2018 Board hearing. Following the Board hearing, CARB continued to assess issues raised by opponents of the Standard and received additional input from several members of the Assembly. Based on consideration of these issues and input, CARB is releasing an updated Standard. The updates serve to strengthen, bolster, and clarify provisions of the Standard to further address stakeholder comments. The Standard provides a strong signal to value the preservation of tropical forests over continued destructive activities such as oil exploration and extraction, and establishes rigorous social and environmental safeguards for indigenous peoples and local communities. While endorsement of the Standard will not result in any change to regulatory programs in California, it will support important actions to address climate change and is available to jurisdictions throughout the world to incorporate into their tropical forest protection efforts.

The originally proposed Standard language from September 2018 was modified prior to the November 2018 hearing based on comments received and those modifications are shown in strikethrough to indicate deletions and <u>underline</u> to indicate additions. Modifications made

since the November 2018 hearing are shown in <del>double strikethrough</del> to indicate deletions and <u>double underline</u> to indicate additions.

## **Environmental Analysis and Response to Comments**

CARB released a Draft Environmental Analysis (Draft EA) for the Endorsement of California's Tropical Forest Standard (Proposed Project) on September 14, 2018, for a 45-day public review and comment period that concluded October 29, 2018. During the public comment period for the Proposed Project, 76 unique comment letters were received. Two additional letters were received after the close of the comment period resulting in a total of 78 unique comment letters received on the Proposed Project. CARB staff carefully reviewed all comment letters received to determine which ones raised significant environmental issues related to the analysis in the Draft EA and required a written response under CARB's certified regulatory program implementing the California Environmental Quality Act (CEQA). At the end of the initial public review process, CARB prepared a Final EA and response to environmental comments prior to the November 2018 Board hearing.

This updated Standard includes modifications to further strengthen, bolster, and clarify the Standard. None of the modifications presented in the updated Standard released along with this Notice alter any of the types of foreseeable compliance responses evaluated or conclusions reached in the Draft EA, introduce new significant effects on the environment, or provide new information of substantial importance relative to the EA. As a result, these revisions do not require recirculation of the draft document pursuant to the CEQA Guidelines, California Code of Regulations, title 14, section 15088.5, before consideration by the Board. However, CARB may prepare a revised Final EA prior to the meeting to document as accurately as possible the modifications proposed to the Standard.

#### Proposed Action

CARB staff will present a written updated California Tropical Forest Standard, as well as the Final EA and Response to Comments, for the Board's consideration and potential approval at the meeting.
