The Air Quality Advisory Committee provides technical peer review to the Office on its recommendations to the Board for California ambient air quality standards. At the October meeting, the Committee will discuss the Office's review under SB 25 (1999 Legislative Session) of California's health-based ambient air quality standards. This review is intended to determine whether, based on public health, scientific literature, and exposure pattern data, the standards protect the health of the public, including infants and children with an adequate margin of safety. The agenda will include discussions on the health-protectiveness of the ambient air quality standards for carbon monoxide, nitrogen dioxide, ozone, sulfur dioxide, particulate matter, sulfates, lead, and hydrogen sulfide.

This meeting is intended to help decide which standards should be selected for a full review and possible revision over the next few years. This is not intended to include recommendations for specific forms or levels of any particular standard found to be inadequate to protect public health.
