The California Air Resources Board (ARB) staff invites you to participate in a public consultation meeting to discuss possible regulatory approaches to reduce particulate matter (PM) emissions from new and existing diesel-fueled engines. This meeting will focus on the development of Air Toxic Control Measures (ATCMs) for those diesel-fueled engines used in stationary applications and transportation refrigeration units (TRUs). The ARB approved the *Risk Reduction Plan to Reduce Particulate Matter Emissions from Diesel-Fueled Engines and Vehicles* (Diesel Risk Reduction Plan) in September 2000. The Diesel Risk Reduction Plan outlined a comprehensive program to significantly reduce diesel PM emissions from new and existing diesel vehicles and engines that operate in California. Last February we held the first public workshop to discuss the Diesel Risk Reduction Plan as it pertains to stationary engines used in agricultural and non-agricultural operations, as well as those engines used in TRUs. Since the February workshop, we have been working to refine the regulatory concepts

that will be used to develop the stationary engine and TRU ATCMs. In this second workshop, we will share with you our current proposed regulatory concepts, results from a survey of diesel engines in California, and our plans for demonstrating the effectiveness of diesel control technologies.
