### METHOD SUMMARY

The amount of bread produced by commercial bakeries in California was determined by multiplying the value of shipments in 1997 by the ratio of lbs/\$ for each product type. Retail bakery production in California was disaggregated from nationwide data. Production for Sacramento County was determined by proportioning out the number of employees in small vs. large establishments using counts of facilities by staff size, then distributing employment numbers by type of facility, either commercial or retail.
