Dear Ms. Yoshii:

The Air Resources Board (ARB or Board) hereby submits to the U.S. Environmental Protection Agency (U.S. EPA) regulations that implement restrictions on agricultural fumigant methods. The Department of Pesticide Regulation (DPR) adopted these regulations on April 20, 2009. These regulations achieve emission reductions needed to comply with DPR's State Implementation Plan (SIP) commitment to reduce pesticide VOC emissions.

On January 28, 2008, ARB submitted to U.S. EPA an earlier version of these regulations. The regulations being submitted today replace the January 28, 2008 submittal in its entirety.

This package consists of two hard copies and one electronic copy of the following materials.


