### 2018 Annual Network Reports

Annually, per federal regulations, the California Air Resources Board (CARB) and local air pollution control and air quality management districts (local districts or districts) evaluate the adequacy of the State monitoring network to meet federal monitoring requirements. A more thorough assessment is conducted every five years. These assessments are documented in annual monitoring network reports that are generally prepared and submitted by the Primary Quality Assurance Organization, or PQAO. The PQAO is the umbrella under which monitoring agencies are organized to ensure that monitoring is conducted in accordance with a common set of procedures, uses common calibration facilities and standards, and is overseen by a single air quality organization.

Although the majority of California's districts are included in the CARB PQAO, the Bay Area Air Quality Management District, San Diego County Air Pollution Control District, and South Coast Air Quality Management District operate as separate individual PQAOs. Each of California's four PQAOs is responsible for its monitoring network and reports directly to the United States Environmental Protection Agency (U.S. EPA) on monitoring network requirements. The most recent annual monitoring network report for each California PQAO is available on the web. In addition, several local districts included in the CARB PQAO compile their own annual report.
