### NOTICE OF PUBLIC MEETING TO CONSIDER CALIFORNIA INFRASTRUCTURE STATE IMPLEMENTATION PLAN REVISION FOR THE 0.070 PARTS PER MILLION FEDERAL 8-HOUR OZONE STANDARD

The California Air Resources Board (CARB or Board) will conduct a public meeting at the time and place noted below to consider adoption of the California Infrastructure State Implementation Plan Revision for the 0.070 Parts Per Million Federal 8-Hour Ozone Standard (Infrastructure SIP Revision). The proposed revisions to California's State Implementation Plan (SIP) are administrative in nature and describe the authorities, resources, and programs California has in place to implement, maintain, and enforce the National Ambient Air Quality Standards (federal standards or standards). This proposed Infrastructure SIP Revision has been prepared to demonstrate California's capabilities to implement the federal 8-hour standard of 0.070 parts per million ozone, set by the United States Environmental Protection Agency (U.S. EPA) in 2015. Included is an assessment of potential significant interstate pollution transport impacts on ozone levels in other states. If adopted, CARB will submit this Infrastructure SIP Revision to U.S. EPA as a revision to the California SIP.

This item will be considered at a meeting of the Board, which will commence at 9:00 a.m., September 27, 2018, and may continue at 8:30 a.m., on September 28, 2018. This item is scheduled to be heard on the Board's Consent Calendar. All agenda items on the Consent Calendar – unless removed upon the request of a Board member or if someone in the audience submits a request-to-speak card on that item – will be voted on by the Board at the beginning of the public meeting.

#### Background

Infrastructure SIP requirements are specified in Section 110 of the federal Clean Air Act (CAA). Infrastructure SIP elements include authority to adopt, implement, and enforce regulations, and demonstration of sufficient personnel and resources to implement the federal standards. The CAA refers to these collectively as the necessary "infrastructure." The Infrastructure SIP describes the programs in place to address these elements and provides reference to the authority under which the programs are

administered. Under the CAA, states are required to submit an Infrastructure SIP to U.S. EPA within three years of the promulgation of each new or revised federal standard.

The infrastructure for California's air quality programs is well established, and most of the Infrastructure SIP elements were addressed in California's comprehensive Infrastructure SIP, submitted to meet the requirements of the 1970 CAA and approved by U.S. EPA in 1979 (40 Code of Federal Regulations Part 52.220). CARB has submitted several Infrastructure SIP revisions since that time in response to new or revised federal standards, most recently in 2014. The proposed Infrastructure SIP revisions that are the subject of this notice build on California's previous submittals. The federal ozone standards covered in the proposed Infrastructure SIP, as well as those addressed in previous infrastructure SIPs, are summarized in Table 1.

This update, which constitutes a revision to California's overall SIP, addresses the required infrastructure elements, including California's ability and authority to monitor and report emissions and air quality data, to adopt and enforce regulations and programs designed to protect public health, to assess and account for potential interstate pollution transport impacts, to provide opportunity for input and review by affected entities and the public, to provide for Board composition and conflict of interest disclosure that conforms with federal requirements, and to maintain adequate personnel and resources to implement the required programs. Because of their general nature, many elements of the proposed Infrastructure SIP may be applicable to new or revised standards that U.S. EPA promulgates.

CARB staff has prepared a proposed Infrastructure SIP documenting the required infrastructure elements and will ask the Board to approve the proposed infrastructure SIP. After adoption, staff will transmit the Infrastructure SIP to U.S. EPA. Upon approval by U.S. EPA, the Infrastructure SIP will be incorporated as a revision to California's overall SIP. Revised Infrastructure SIPs for the 0.070 ppm 8-hour federal ozone standard are due to U.S. EPA by October 2018.

### Proposed Action

CARB staff recommends that the Board adopt the proposed revision and direct staff to submit it to the U.S. EPA as a revision to the California Infrastructure SIP.

CARB staff will have available a written report at the meeting.
