The Air Resources Board (ARB) requests that the United States Environmental Protection Agency (U.S. EPA) find the Yuba City-Marysville 24-hr PM2.5 nonattainment area in attainment for the 2006 24-hour fine particulate National Ambient Air Quality Standard (NAAQS). This request is based upon review of quality assured and certified PM2.5 data that show attainment of the NAAQS during the 2006-2008 period with continued attainment through the 2007-2009 period. In addition to making a finding of attainment, we also request that U.S. EPA suspend the attainment plan and progress plan requirements. ARB recognizes that a finding of attainment under the Clean Air Act does not constitute a redesignation to attainment.

On October 8, 2009, the Yuba City-Marysville area was designated nonattainment for the 2006 24-hr PM2.5 NAAQS. An area is considered to be in attainment of the 24-hour PM2.5 standard when the design value is less than or equal to 35 µg/m³. The 24-hour design values for Yuba City-Marysville area are 33 µg/m³ and 28 µg/m³ for 2006-2008 and 2007-2009 monitoring periods, respectively, as illustrated by Table 1 in the enclosure. These design values are valid for a comparison to the NAAQS because they meet completeness criterion for each quarter within the applicable three-year period. However, the 2008 and 2009 design values exclude data affected by exceptional events, as shown in Table 2 in the enclosure. These data have been flagged in U.S. EPA's Air Quality System database and the documentation was submitted to U.S. EPA on August 28, 2009.

Under U.S. EPA's Clean Data Policy, a finding of attainment supports suspension of certain State Implementation Plan requirements, such as attainment and progress plans so long as the area remains in attainment or until the area completes the requirements to be redesignated to attainment. Since the Yuba City-Marysville area now meets the
