The Air Resources Board (ARB) is submitting to the U. S. Environmental Protection Agency (U.S. EPA) the Yuba City-Marysville PM2.5 Nonattainment Area Redesignation Request and Maintenance Plan (Plan). The Feather River Air Quality Management District adopted the Plan on April 1, 2013 and transmitted it to ARB on April 2, 2013. ARB approved the Plan on April 25, 2013 as a revision to the California State Implementation Plan (SIP).


