Dear Mr. Nastri:

The Air Resources Board (ARB) hereby submits as a revision to California's State Implementation Plan (SIP) the <u>2008 Owens Valley PM10 Planning Area</u> <u>Demonstration of Attainment State Implementation Plan</u> (2008 Plan). We request that the U.S. Environmental Protection Agency (U.S. EPA) act expeditiously to find the 2008 SIP Revision complete, and fully approve it as an enforceable framework for actions taken to attain the PM10 national ambient air quality standard (NAAQS) in the Owens Valley.

On February 1, 2008, following a public hearing, the Great Basin Unified Air Pollution Control District (District) adopted the 2008 Plan. The 2008 Plan reflects a settlement agreement reached between the District and the City of Los Angeles (City) concerning the level of additional control needed on the Owens dry lakebed to attain the PM10 NAAQS. As part of the settlement agreement, the District agreed to revise the 2003 SIP before March 1, 2008 to incorporate the provisions of the settlement. This 2008 Plan fulfills the District's commitment and demonstrates that the NAAQS will be attained at the lakeshore by March 23, 2012. The 2008 Plan also notes the possibility that an extension to 2017 may be needed as allowed under Clean Air Act section 179(d)(3).

The 2008 Plan requires the City to implement dust control measures on an additional 13.2 square miles of the lake bed by April 1, 2010. It demonstrates that the proposed level of control will reduce emissions from the Owens lake bed by more than five percent per year from lakebed dust emissions levels in 2006, the emission inventory baseline year for this planning effort.

As a contingency measure, the 2008 Plan requires the District's Air Pollution Control Officer to assess the effectiveness of the control program at least once per year after May 10, 2010, and to require the City to implement supplemental controls if they are needed to attain and maintain compliance of the NAAQS. The settlement negotiated between the District and the City includes an opportunity for the City to appeal a determination to ARB as allowed under California Health and Safety Code section
