The Air Resources Board (ARB) is submitting to the U.S. Environmental Protection Agency (U.S. EPA) the 2013 Amendment to the Owens Valley PM₁₀ SIP (2013 Amendment). The Great Basin Unified Air Pollution Control District (District) adopted the 2013 Amendment on September 16, 2013.

This submittal includes one paper copy and one electronic media copy of the materials identified as follows.

- I) The District transmittal package, including
 - A) A September 25, 2013, transmittal letter to Richard W. Corey, ARB Executive Officer, from Theodore D. Schade, District Air Pollution Control Officer.
 - B) An Affidavit of Service of the Clerk of the District Board certifying the 30-day public notice for the September 16, 2013, public hearing and the compilation of documents contained in the transmittal package.
 - C) Copies of the posted and published 30-day public notices for the September 16, 2013, public hearing and a list of the names of recipients of mailed and emailed copies of the notice.
 - D) A Minute Order of the Clerk of the District Board certifying Board approval of Board Order 130916-01 amending the 2008 SIP on September 16, 2013.
 - E) District Board Order 130916-01 amending the 2008 SIP to revise the Best Available Control Measure (BACM) implementation date for the Phase 7a area, modify the descriptions of BACM, and modify provisions for control of emissions from the Keeler Dunes including exhibits.


