On behalf of the Governing Board of the Great Basin Unified Air Pollution Control District (District), I am transmitting to the California Air Resources Board the *2013 Amendment to the Owens Valley PM<sub>10</sub> SIP*, adopted by the District's Governing Board on September 16, 2013 (Board Order #130916-01). The revisions contained in the 2013 Amendment to the Owens Valley PM<sub>10</sub> SIP are incorporated into the 2008 Owens Valley PM<sub>10</sub> SIP and modify Board Order #080128-01, which specifies the dust control requirements at Owens Lake.

The 2013 Amendment to the Owens Valley PM<sub>10</sub> SIP was adopted after a duly-noticed public hearing that provided an opportunity for written and oral public comment. Enclosed is the Declaration of the District's Board Clerk certifying the facts showing the District's compliance with the notice and public hearing requirements for the 2013 Amendment to the Owens Valley PM<sub>10</sub> SIP, and a copy of the Board Order certifying the adopted SIP revision.
