**Executive Order R-11-011**

*Relating to Amendments to the California Consumer Products Regulations and  
Test Method 310*

WHEREAS, on November 18, 2010, the Air Resources Board (ARB or Board) conducted a public hearing to consider the proposed amendments to the California Consumer Products Regulations and Test Method 310, as set forth in the Initial Statement of Reasons, which was released to the public on September 29, 2010;

WHEREAS, following the public hearing, the Board adopted Resolution 10-40, in which the Board approved the amendments to sections 94508, 94509, 94510, 94512, and 94515, title 17, California Code of Regulations, and the amendments to the incorporated ARB Method 310, as set forth in Attachment A to Resolution 10-40, with the modifications set forth in Attachment B thereto;

WHEREAS, Resolution 10-40 directed the Executive Officer to take final action to adopt the regulatory amendments set forth in Attachment A, with the modifications set forth in Attachment B, and such other conforming modifications as may be appropriate, after making the modified regulatory language available to the public for a period of 15 days, provided that the Executive Officer shall consider such written comments as may be submitted during this period, shall make such modifications as may be appropriate in light of the comments received, and shall present the regulations to the Board for further consideration if the Executive Officer determines that this is warranted;

WHEREAS, on July 20, 2011, the modified regulations, reflecting the amendments approved by the Board and other changes made to best reflect the intent of the Board at the hearing, and additional documents were made available for public comment for a period of 15 days, with the changes to the originally proposed text clearly indicated, in accordance with the provisions of title 1, California Code of Regulations, section 44;

WHEREAS, three written comment letters were received during the 15-day comment period and those comments have been considered by the Executive Officer; and

WHEREAS, the responses to comments on the environmental issues associated with the proposed regulation, which are contained in the Final Statement of Reasons for this regulatory action, have been approved by the Executive Officer.

NOW, THEREFORE, IT IS ORDERED that the recitals and findings contained in Resolution 10-40 are incorporated herein.

IT IS FURTHER ORDERED that the amendments to sections 94508, 94509, 94510, 94512, and 94515, title 17, California Code of Regulations, and amendments to the incorporated ARB Method 310, are adopted as set forth in Attachment I hereto.

IT IS FURTHER ORDERED that the adopted regulatory text may be further revised with nonsubstantive changes, which will be added to the rulemaking record and indicated as such.
