NOTICE OF PUBLIC MEETING TO CONSIDER ADOPTION OF A TECHNICAL REVISION TO THE SAN JOAQUIN VALLEY PM2.5 SIP

The California Air Resources Board (CARB or Board) will conduct a public meeting at the time and place noted below to consider adoption of a revision to the San Joaquin Valley PM2.5 State Implementation Plan (SIP). If adopted, CARB will submit this revision to the United States Environmental Protection Agency (U.S. EPA) as a revision to the California SIP.

This item will be considered at a meeting of the Board, which will commence at 9:00 a.m., May 28, 2020, and may continue at 8:30 a.m., on May 29, 2020. This item is scheduled to be heard on the Board's Consent Calendar, unless removed upon the request of a Board member or if someone in the audience submits a request-to-speak card on this item. Please consult the agenda for the meeting, which will be available at least ten days before May 28, 2020, to determine when this item will be considered.

Background

U.S. EPA has requested that CARB provide a technical revision to an emissions reduction commitment contained in the 2012 PM2.5 Plan. The 2012 PM2.5 Plan was adopted by the District on December 20, 2012, by CARB on January 24, 2013, and approved by U.S. EPA on August 31, 2016 (81 FR 59876). The revision is a translation of a reduction commitment from the inventory used in the 2012 PM2.5 Plan to the most current inventory. U.S. EPA has requested this technical revision to support its current consideration of approval of the 2018 Plan for the 1997, 2006, and 2012 PM2.5 Standards.

Proposed Action

CARB staff recommends that the Board adopt the revision to the San Joaquin Valley PM2.5 SIP and direct the Executive Officer to submit it to U.S. EPA as a revision to the California SIP.

CARB staff will present a written report on the SIP revision at the meeting.
